Discussion Paper - Stakeholder Consultation and Public Engagement, ALR and ALC Revitalization

- 4-CAC The Community Agricultural Commission recommends that Council, on behalf of the District of North Saanich, respond to the Discussion Paper on ALR and ALC Revitalization as follows:
 - 1. That government reaffirm the overarching principle of the preservation and enhancement of soil;
 - 2. A review of the legislation must include as a paramount consideration the strength and preservation and enhancement of the use of the soil for inground production of food;
 - 3. The legislation should not allow the nature and scope of permitted uses to include industries such as mines and LNG, large scale commercial cannabis growing, large scale mushroom and greenhouse operations; and

4. That the government consider incorporating the classes of soils into the ALR land use legislation and that the most arable be limited to in-ground food production.
