

## **ARCHAEOLOGICAL AND HERITAGE SITES**

## Archaeological Sites

Maps from the Archaeological Branch of the BC Ministry of Forests, Lands and Natural Resource Operations have been provided to the District of North Saanich. These maps identify areas that contain or **may** contain archaeological sites which are regulated by the Provincial Government's *Heritage Conservation Act*. It is the responsibility of the registered owner(s) to seek appropriate approvals from the Province prior to commencing any work on the property.

If you are planning to purchase property or if you are planning works to your property, please consult with municipal staff to assist you in determining if your property has been identified to have potential archaeological value as determined by the Archaeological Branch.

Properties which have archaeological significance are subject to compliance with *Heritage Conservation Act* regulations as stipulated by the Archaeology Branch. A copy of written approvals and/or guidance from the BC Ministry of Forests, Lands and Natural Resource Operations is the Government Regulatory Authority for the *Heritage Conservation Act* is required prior to issuance of any permit from the District of North Saanich.

An Archaeological Alteration Permit may be required from the Province if a property is identified to be within an archaeological site or known to have archaeological value.

## **Heritage Sites**

There are twenty one sites on the District of North Saanich Heritage Register. Three of the Heritage Register sites have heritage designation status and are subject to the Provincial Heritage Conservation Act. These sites include: Nymph Point Park, Holy Trinity Church and the Western Red Cedar at Lillian Hoffar Park. A Heritage Alteration Permit (HAP) is required for proposed changes that would affect the heritage value of these properties. An application must be submitted to the District for consideration of the proposed changes and any effects these may have on this heritage value.

The District may also request a review of any proposed changes or alterations to other Heritage Register properties prior to the issuance of a building or development permit.
