BYLAW NO. 1558

A BYLAW TO PROVIDE FOR AN EXEMPTION FROM TAXATION OF CERTAIN LANDS AND IMPROVEMENTS

WHEREAS Section 224 of the *Community Charter* authorizes a Council to exempt land or improvements, or both, from taxation for a period as provided by bylaw;

AND WHEREAS notice of the permissive tax exemptions, as required under Section 227 of the *Community Charter*, has been given;

NOW THEREFORE, the Municipal Council of the District of North Saanich, in open meeting assembled, enacts as follows:

Exemptions

- 1. The lands and improvements described below are hereby declared exempt from taxation for the year 2024 pursuant to Section 224 of the *Community Charter*:
