

Regular Meeting of Council July 12, 2021 at 7 p.m.

Mayor and Council Resolutions on the OCP Review Report - Phase 2 Engagement Summary and Emerging Concepts Report and Phase 3 Engagement Plan

That Council direct staff to amend the Phase 2 Engagement Summary report to include the following information and report back to Council at the earliest possible meeting in the fall after the final Stage 4 British Columbia Public Health Order date (anticipated to be September 7, 2021 at the earliest):

- 1. Summary of the May 19, 2021 Design Charrette mentimeter comments.
- 2. Summary of the June 2021 Big Concepts pop-up sessions including an estimate of the number of participants and the feedback received.
- 3. Summary of correspondence received during Phase 2 including the number of items and general themes.
- 4. Comment on how the summary information referenced in points 1-3 may or may not align with the other Phase 2 engagement feedback documented in the report.
- 5. Provide a more detailed rationale that clearly indicates how the Big Concepts emerged from the feedback received prior to and during the May 17-19, 2021 Design Charrette sessions.
- 6. Revise the Executive Summary to include more commentary related to: Phase 2 desired outcomes, Key Themes summary information, rationale for the Big Concepts, and an assessment of the effectiveness of the Phase 2 engagement activities.

That Council direct staff to report back to Council with the following information at the earliest possible meeting in the fall after the final Stage 4 British Columbia Public Health Order date (anticipated to be September 7, 2021 at the earliest):

- 1. An assessment of what the Project Team feels went well during Phase 2 engagement and whether there were any aspects of the engagement that could be improved upon as we look to establish both scope and schedule for Phase 3 engagement.
- 2. Provide commentary related to how the build-out capacity of the existing land base and associated zoning will be used to inform Phase 3 decisions related to dwelling unit quantity, type and location for the 20-year Official Community Plan period.
- The overall project schedule and expenditure impact of the pause associated with these OCP Review motions and potential additional amendments to the Phase 3 Engagement Plan such as:
 i) additional open house sessions with distinct North Saanich neighbourhoods, ii) a revised and more active role of the Advisory Working Group, iii) improved community awareness using existing or new methods., iv) an emphasis on community engagement in face-to-face meetings.

That Council direct staff to schedule a facilitated workshop with Council and the Project Team in advance of Council receiving the amended Phase 2 Engagement Summary and Emerging Concepts report, and the supplementary staff report. The objective is to allow additional review and discussion related to:

- 1. The Big Concepts introduced on May 19, 2021 and how these concepts might be revised or eliminated as the process moves forward.
- 2. Phase 3 Engagement and the how any suggested modifications will impact the project schedule and expenditure.
- 3. Preliminary Vision and Goals and how to approach the review of these important and foundational Official Community Plan items.
