#### A BYLAW TO DESIGNATE BYLAWS TO BE ENFORCED BY MEANS OF MUNICIPAL TICKETING

WHEREAS the *Community Charter*, SBC 2003, c 26 authorizes the Council, by by-law, to designate those by-laws for which municipal ticket information may be used as a means of by-law enforcement;

AND WHEREAS the *Community Charter*, SBC 2003, c 26 authorizes the Council to, by by-law, set the fine amounts of each municipal ticket information;

NOW THEREFORE, the Municipal Council of the District of North Saanich, in Open Meeting Assembled, ENACTS AS FOLLOWS:

1. This By-law may be cited as “**North Saanich Municipal Ticket Information Bylaw No. 1544 (2022)**”.

2. **REPEAL**

“**North Saanich Municipal Ticketing Information Bylaw No. 1013 (2002)**”, and all its amendments are hereby repealed.

3. **CITATION**

This Bylaw may be cited as the “**North Saanich Municipal Ticketing Information Bylaw No. 1544, 2022**”.
