A BYLAW TO AMEND DISTRICT OF NORTH SAANICH OFFICIAL COMMUNITY PLAN BYLAW NO. 1130 (2007)

The Council of the District of North Saanich, in open meeting assembled, ENACTS AS FOLLOWS:

TEXT AMENDMENTS

1. The text of the District of North Saanich Official Community Plan Bylaw No. 1130, (2007) is hereby amended as follows:

- a. In Section 17.0 Plan Area Inventory is amended by removing the text within the row of the table 'Agriculture' and replacing it with:

Agricultural	1,145 ha	31.06%

- b. In Section 17.0 Plan Area Inventory is amended by removing the text within the row of the table 'Community Uses' and replacing it with:

Community Uses	48 ha	1.3%

- c. In Section 17.0 Plan Area Inventory is amended by removing the text within footnote 1 'September 2019' and replace with 'October 2022'

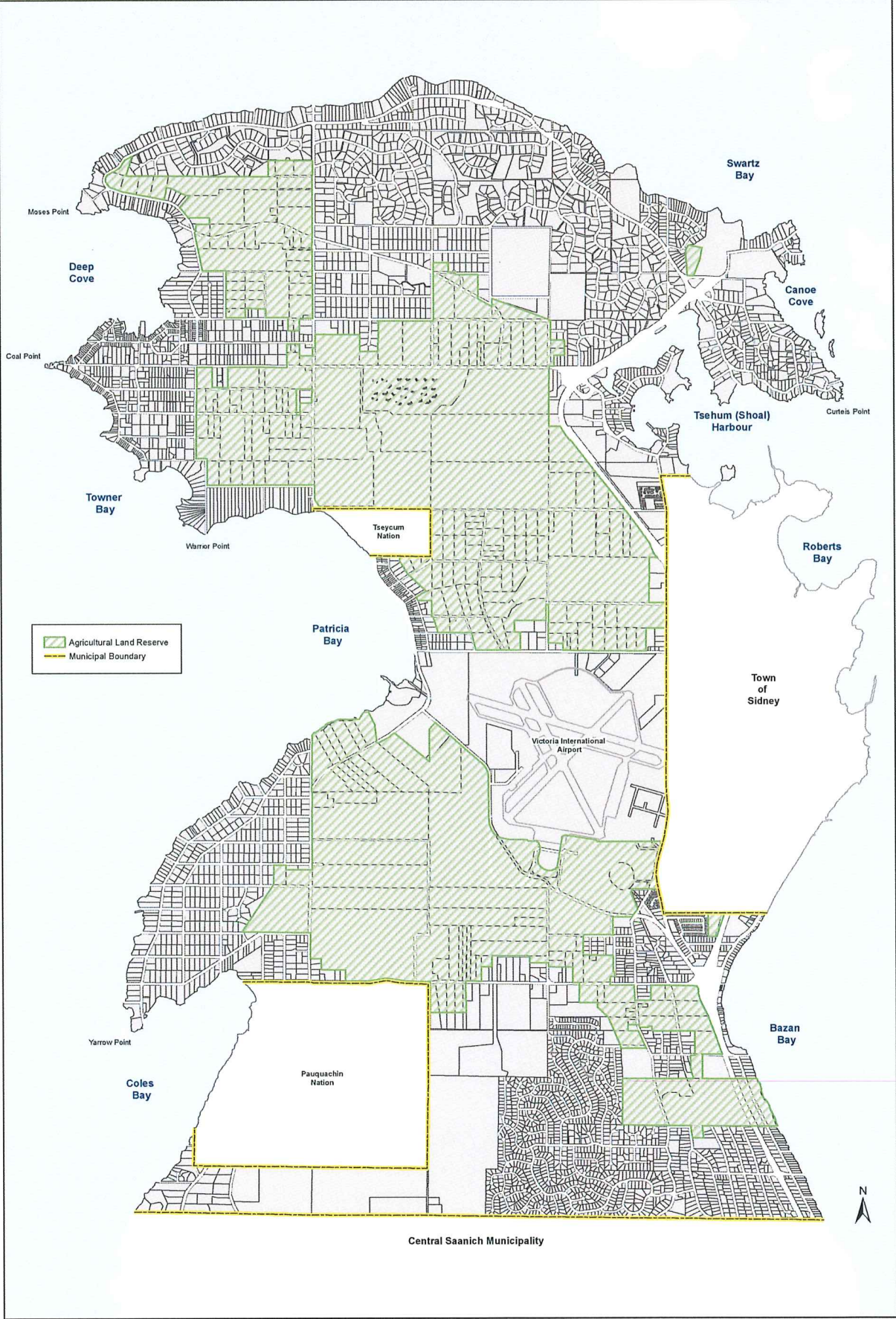
